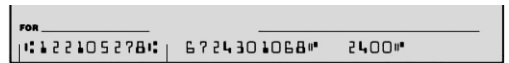

### Waive Pre-Note Cycle

I/we wish to waive the pre-note cycle. A pre-note is a test transaction that is sent to your bank account to ensure that the account numbers are valid. By agreeing to waive the pre-note cycle, it is understood that if for some reason the account information you supply is incorrect and the transfer is rejected, both the depositing and receiving banks have up to five (5) business days to notify Crown Castle of the returned funds. Therefore, Crown Castle cannot reissue funds in any form until it is confirmed that the funds have been returned. By checking here and signing below you are agreeing that if the transfer is rejected, you will not make any claim against Crown, nor will you exercise any rights you may have in the original ground lease between Crown Castle and you to declare a default because of the electronic funds rejection.
